## NASD Acceptable Use Policy and Publication Agreement 2020-2021



Dear NASD Parent or Guardian:

The Nazareth Area School District provides all students with access to the local area computer network and the Internet. We consider the computer network and Internet access to be a valuable instructional tool and encourage the use of computers and computer-related technology in district classrooms. As part of our curriculum, we encourage teachers and students to make use of educational resources available on the Internet. We also provide students with access to specific web-based instructional software that relates directly to the curriculum taught. Access to the Internet and web-based instructional software enables students to deepen their understanding of the curriculum as well as conduct research and obtain high quality and age appropriate educational resources from libraries, museums, galleries and other information sources from around the world.

To protect our children, the district network has a content filter to block as many objectionable Internet sites as possible and has adopted an Acceptable Use Policy (AUP) that outlines the expectations and procedures set by the district for the acceptable student use of technology. This policy is posted on the district web site. To access the policy on the district website select the "Departments" tab at the top of the page, use the pull down menu to select "Information Technology," and the Acceptable Use Policy can be found on the left-hand side of the screen. Copies of the Acceptable Use Policy are also available for you at your child's school upon request. Please take a few minutes to review the policy with your child.

In addition, from time to time student photographs and/or class-work may be posted on an individual school or the district web page or social media. Likewise, student photographs and/or class-work may appear in a school or district publication, for example, a yearbook, calendar or newspaper. Please read and respond to the choices below so that the district can comply with your wishes in regards to the publication of student photographs and/or class work. If the form is not completed, the district will assume there is no objection on your part. This form will be kept on file while your child is attending his or her current school. It will be reissued when your child transitions to another building in the Nazareth Area School District.
